WEF 01.09.2019, UGC has stopped Automatic Conversion from JRF to SRF. The University/Institute may upload the 3 member commettee Report in PDF Format vide option Transaction Data Entry >> JRF to SRF Upgradation. This needs to get approved by UGC. Once UGC Approves the upgradation, then only the Candidate will be getting payments at SRF Rate.

-Earlier many scholars were getting the benefits of Automatic Conversion, where the scholars were not upgraded as SRF by the University/Institute. Such scholars whose upgradation is pending in system and where getting SRF Payment due to SRF Upgradation, will not be getting the payment at SRF Rate untill the Upgradation gets uploaded by University/Institution and approved by UGC.

NETJRF Scholars who has completed 3 years and not upgraded to SRF in system, will not be getting any payment until the SRF Upgradation gets approved by UGC

For Linking any Student ID to the UGC Portal, University/Institute may mandatorily scan and upload the Joining Report in PDF Format. The Master Data for new selection for Scholarship schemes NFOBC, SVSGC and MANF are available for linking. Universities/Institutions may link the Student IDs.
