3. Regular review of progress of work by the scholars by the Research Progress Assessment Committee (RPAC) in accordance with the provisions of the statutes should be ensured.
4. Pre-BORS meetings should be convened by Dean of the School wherein the proposed topics of research to be assigned to the scholars should be thoroughly discussed and opinion and advice from experts available in other departments/centres wherever required should also be sought.

He also emphasized on the strict adherence to the statutes governing the research programmes in the University.
