At the outset, Dean Research requested the Hon'ble Vice-Chancellor for his valuable introductory remarks. The Vice-Chancellor informed the members about the selection of the University for support under the **Component 10: Research, Innovation and Quality Improvement** of RUSA, Ministry of Human Resource Development, Govt. of India. The Vice chancellor also informed the members about the evaluation of the proposals submitted by faculty members by an Expert/Apex Committee constituted for the purpose and also underscored the need for submission of research proposals to other agencies for financial support. The Vice-Chancellor desired that BORS meetings should be held regularly after every six months.

In his remarks, Dean Research emphasized on:

- 1. Timely conduct of examination and declaration of results of three course work papers and regular evaluation of the progress of research work through the RPAC.
- 2. Identification of cross-cutting themes of research and active collaboration with institutions of national and international eminence.
- 3. Review of research progress in the school/faculty by the Dean of the concerned School/Faculty and formulation of relevant and well thought-out proposals aimed at promotion of quality research for considered of Research Council and other statutory bodies.

- 4. Strict adherence to the statutes governing admission to research degree programmes, assessment of progress of work and evaluation of dissertation/theses.
- 5. Deans of the Schools should come up with detailed reports about status of research work carried out by the scholars registered during the previous meeting of the BORS.
- 6. Admission process to the research degree programmes should be completed in a time-bound manner.
